Line 29 - Program Accomplishments (Save a Girl / Save a Widow program)

Assistance to individuals, including our "Save a Girl" campaign designed to empower women in China to resist pressure to abort or abandon their baby girls and to help women fleeing to escape forced abortion. The program offers these women a monthly stipend to assist in caring for their babies. The program also offers a monthly stipend to destitute widows. Approximately 50 women were empowered through our program in 2017; around 50 babies were saved. Additionally, assistance was provided to Anni Zhang, daughter of former political prisoner and human rights activist Zhang Lin. Anni is currently a refugee in the United States who left China due to human rights abuses, including Anni's kidnapping and detention by authorities at age ten and the denial of her right to attend school.

Widows in China are the invisible victims of the One Child Policy. Many are destitute because their husbands have died and their child or children do not care for them. Senior suicide is on the rise. We are building a campaign, to be launched in September 2018 to support such widows, restoring dignity and hope in their lives.
